### Note from the United Kingdom of 9 August 2021

<u>Subject:</u> Images of the European Health Insurance Cards (EHIC) and Global Health Insurance Cards (GHIC) circulated by the UK Government

The UK presented a note (A.C. 051/21) which set out the UK Government's steps on implementing the social security coordination provisions of the Withdrawal Agreement and the Protocol on Social Security Coordination of the EU – UK Trade & Cooperation Agreement. This note provides the relevant images for the UK-issued Health Insurance Cards in circulation, as requested by the Administrative Commission secretariat.

The UK has provided a similar notification to the Specialised Committee on Social Security Coordination, as per the obligations set out in the Protocol on Social Security Coordination.

#### Student CRA EHIC

The Withdrawal Agreement student EHICs are distinguished by country specific text in the PIN and should continue to be accepted by healthcare providers in that Member State as evidence of an individual's entitlement to necessary healthcare under the Withdrawal Agreement.

In addition, given students also have rights under the Protocol, we ask that under Article SSCI.75 of the Protocol, those new student CRA EHICs are accepted by healthcare providers in all other EU Member States as evidence of an individual's entitlement to necessary healthcare. The Specialised Committee on Social Security Coordination have also been notified.
