



HOUSING

ESSENTIAL FOR INTEGRATION





IN FINLAND A quarter of homeless families are immigrants



IN BARCELONA, SPAIN, 52.3% of homeless people are thirdcountry nationals.



IN GREECE 16% of the 3,774 unaccompanied minors are sleeping rough.



Challenges regarding integration in the area of housing

- Critical lack of affordable housing across the EU
- In 2018, non-EU nationals were on average 2.4 times more likely to be overburdened by housing costs (24%) than nationals from reporting countries (9.9%). EUSILC (2020)
- Lack of comparable data & common definitions
- Economic and/or Social Marginalisation
- Insufficient time to search for accommodation after obtaining refugee status
- Discrimination
- Legal and administrative obstacles
- Inability to access public funding
- Lack of Support Legislation for Access to Housing
- Women specific:
- Gender-based violence
- Dependent migrant status



Solutions to the housing crisis ightarrow

- Using social housing, identifying specific needs and individualised support
- Self-restoration of dilapidated housing, between reception policies and urban renewal
- Makeshift systems and civil society solutions
- Use of vacant private housing

Housing First has demonstrated unprecedented success in solving homelessness for those considered « hardest » cases.

Provide homeless migrants with long term housing solutions

- Affordable and adequate shelter.
- Facilitate integration overall.
- Allow for access to education/training and access to the labour market.



• "Since I am undocumented, I am entitled to nothing. Only the shelters of Red Cross and SamuSocial accept undocumented people, but just for one night. Every day you have to call them to know if they will have a bed for you, but you have to call them 200 times because lines are always collapsed... There is not a long-term accommodation option for me at all. How can I plan anything if I don't know whether I will be sleeping on the streets tonight? How will I take care of my daughter? That's why I am living with this man. Despite he is sometimes violent, at least my daughter and I sleep with a roof above our heads."
