#### 4.1. European Homelessness Count

##### Priorities of the year, objectives pursued and expected results

This Pilot Project will contribute to the objectives of a fair transition for better employment, working conditions and social inclusion.

The activity will complement surveys in the income and living conditions domain on housing difficulties, undertaken by EUROSTAT, pursuant Regulation (EU) 2019/1700 of the European Parliament and of the Council. The expected results are to inform about the scope of homelessness, and its different dimensions and profiles.

The action will be implemented at city level in different Member States to ensure an adequate geographical balance across the EU.

##### General description of the contracts envisaged

The aim of this action is to stimulate a regular data collection on homelessness at the local level. It is continuation of the pilot project `European Homelessness Count` (to be implemented in 2023 - 2024) which focuses on

1) identifying a common operational definition of homelessness and a common data collection methodology,

2) testing it in a limited number of cities in different Member States. In this second stage, the action will focus specifically on:

- refining the common counting methodology defined in the first stage,

- coordinating and implementing a round of a common European Homelessness Count simultaneously in a larger number of cities and Member States.

The results will show the extent of homelessness, and its different dimensions and profiles.

**9.1. Pilot project: Best practices in organisation and reduction of working time in Europe****Priorities of the year, objectives pursued and expected results**

In the current context of high labour shortages and changes in working practices triggered by the Covid-19 pandemic, including the shift towards teleworking, working time reduction is high on the political agenda. By examining evidence on this issue, the pilot project will contribute to the objective of a fair transition for better employment, working conditions and social inclusion.

The pilot project will summarize strengths and weaknesses of the different working time reduction practices across EU Member States and their impact on several individual, company and societal outcomes (including on job quality, work-life balance, productivity and training take-up).

The best practices of working time reduction will be disseminated to a broad audience.

**General description of the implementing measure**

This action will address the lack of overview on working time practices in Europe. It will include the following activities: collect evidence on working time reduction and reorganisation practices implemented by companies; gather information on working time reduction policies implemented by governments in Europe; organise meetings with stakeholders to exchange

views on working time reduction experiences; evaluate advantages as well as disadvantages and publish results.
