Background

Every person has the right to be included in the society. For this to become a reality, the European Union and all member states need to promote, protect and ensure the full and equal enjoyment of all human rights and fundamental freedoms for all persons with disabilities. To promote respect for the inherent dignity of all, national strategies can be used to break the still existing barriers for persons with disabilities to participate fully in society and the labour market on an equal basis with others. There are promising examples on how to succeed.

The EU and its member states are parties to the UN Convention on the Rights of Persons with Disabilities (CRPD). Parties to the CRPD, use regional and national strategies and action plans to implement and monitor the progress.

In this seminar, examples of policy frameworks as well as practical solutions on how to improve equality through the strategic use of accessibility will be presented and discussed. Methods for including persons with disability in the development processes of all matters that concern them will also be highlighted.

Our aim is to contribute to the implementation of the EU Strategy for the Rights of Persons with Disabilities, with a specific focus on EU Member State experience. The program will include presentations and interaction around experiences and examples that inspire and increase knowledge. As a contribution to the knowledge and experience exchange, the Swedish Agency for Participation has drafted a report with an overview and examples of national disability strategies in Europe. The report was drafted through interaction with the secretariat and members of the European Disability Platform and will serve as a background material to the seminar.
