## Annex 2: Underlying data and detailed information on measures to address energy poverty and high energy prices, and to cushion the impact of high inflation in general

This annex contains summary tables of the data provided by ISG delegates under the 2023 collection of administrative data on government measures to address energy poverty and high energy prices in Member States. Note that the data and results of the data collection are not comparable across countries. The measures in scope of the data collection have been rearranged into 3 categories of measures:

(a) *Measures to combat energy poverty by directly improving the affordability of residential energy*

- o A.1) Ad-hoc income-support/heating allowance aimed at cushioning the impact of high energy prices
- o A.2) Caps on energy prices or reduction in energy tariffs
- o A.3) VAT or other tax reductions on energy consumption

(b) *Measures to ensure access to a certain (minimum) level of residential energy*

- o B.1) Measures against energy disconnection (cut-offs)
- o B.2) In-kind supply of energy (incl. minimum quota)

(c) *(Measures aimed at cushioning the impact of high inflation in general (thus measures whose specific purpose is not exclusively to face high energy prices but which are expected to contribute to help cope with them).*

- o C.1) Other ad-hoc income-support measures (not related to increases in standard benefits) aimed at cushioning the impact of high inflation in general
- o C.2) Increases in standard benefits aimed at cushioning the impact of high inflation in general

Data was generally collected on the “main” measures for each type of measure. As an indication, the “main” measures for a given type of measure would be:

- The main two measures (i.e. largest in actual expenditure amount<sup>1</sup>) – in the elapsed quarter - of the *not targeted measures* under this measure type.
- As well as the main two measures (i.e. largest in number of recipients) – in the elapsed quarter - of the *targeted measures* under this measure type.

It is important to highlight that any measure related to wages are excluded from this data collection.

The data collected on each measure covers the **name** of the measure (both in national language and in English translation), whether this measure is **targeted or not** to specific households/persons (and any relevant comment about this), and

- *For the measure types A1-A3, B1-B2 and C1:* Quarterly data on: 1) the number of recipients (incl. the unit, e.g. at person/household level) at the end of the elapsed quarter and on 2) the related expenditure amount (in national currency) during this quarter, for the main measures provided.
- *Only for the measure type C.2) Standard benefits:* Quarterly data on the actual level of increase (in % change from the previous quarter) in the amount of the considered benefit provided for the following standard benefits: i) minimum income benefits, ii) unemployment benefits, iii) family benefits, iv) housing benefits and v) pension benefits. The “actual level of increase (in %)” refers here to an increase in the amount of a standard benefit – whether this increase is related to indexation strictly speaking or not – with this increase aiming at partially or fully cushioning the impact of higher energy prices or of inflation in general.

<sup>1</sup> The number of recipients may also be used but, since not targeted measures are in principle targeting the whole population, this may not be a useful criterion to determine which ones of them are the 2 main ones.
