Declaration by the Republic of Poland pursuant to Article 9 of Regulation (EC) No 883/2004 of the European Parliament and of the Council of 29 April 2004 on the coordination of social security systems for the year ending 31 December 2022

I. DECLARATIONS REFERRED TO IN ARTICLE 1(L) OF REGULATION (EC) No 883/2004 AND THE DATE AS OF WHICH THE REGULATION APPLIES

Regulation (EC) No 883/2004 of the European Parliament and of the Council has applied to the legislation listed below, insofar as it falls within the scope of that Regulation, since 1 May 2010, with the exceptions set out below. It is also the date as of which the Regulation has applied in Poland.

The Act of 29 October 2021 amending the Personal Income Tax Act, the Corporate Income Tax Act and certain other acts (Journal of Laws, item 2105), introduced a new title to compulsory health insurance as of 1 January 2022. Persons appointed to perform duties by virtue of an act of appointment and who receive remuneration on that basis became subject to compulsory health insurance.

The purpose of the amendment was to give persons appointed to perform duties by virtue of an act of appointment who receive remuneration on that basis the same rights and obligations as persons subject to compulsory health insurance. Those concerned include persons performing the duties of members of the management board, members of the audit board and members of examination boards.

The obligation to provide those persons with health insurance arises on the date of their appointment and expires on the date of termination. The entity paying their salary has to declare them for health insurance.

Amendments concerning entitlement to sickness benefit despite arrears in the payment of contributions

The new provisions allow persons who are unable to work during a period in which they have arrears of more than 1% of the minimum wage to qualify for the benefit. They will qualify after settling the debt. However, if the debt remains unsettled 6 months after the date on which they qualify for the benefit, their entitlement will be time-barred. A debt of less than 1 per cent of the minimum wage does not prevent payment of the benefit.

Amendments concerning introduction of a higher benefit for hospital stays

Prior to the entry into force of the amendment, the amount of the benefit for the period of a hospital stay was 70 per cent of the basis for calculating the benefit. Since the entry into force of the amendment, the amount of the benefit for the period of a hospital stay has been 80 per cent of the basis for calculating the amount of the benefit.

Amendments concerning the recalculation of the basis for the amount of the benefit

Since the entry into force of the amendment, it is no longer necessary to recalculate the amount of the benefit if there was no interruption between the periods of receipt of the

benefits (regardless of their nature) or if the interruption was shorter than one calendar month. Before the amendment, the basis for the amount of the benefit was recalculated if there was an interruption of at least 3 calendar months.

Amendments aimed at simplifying the calculation of the benefit period

The benefit period is 182 days and represents the entire period during which sickness benefit may be paid. All uninterrupted periods of incapacity for work, even if the causes differ, are included in the same benefit period. Before the amendment, if there were interruptions in incapacity for work, the previous incapacity for work was included in the benefit period, provided that it was caused by the same illness and the interruption did not exceed 60 days.

Since the amendment, the reason for incapacity for work before and after the interruption has been irrelevant. However, periods of incapacity for work prior to an interruption of up to 60 days are not included in the benefit period if, after the interruption, the incapacity for work occurs during a pregnancy.

Amendments aimed at reducing the benefit period after the expiry of insurance

In the light of the new rules, sickness benefit may be paid for up to 91 days after leaving employment.. This does not apply to persons with tuberculosis, who are unable to work during pregnancy and are unable to work as a result of the necessary medical examinations for potential donors of cells, tissues and organs and for the taking of cells, tissues and organs.

A person who has drawn sickness benefit for the maximum period but is still unable to work may apply for rehabilitation benefit. That benefit is payable for a maximum period of 12 months if a person is expected to recover their capacity for work after further treatment or rehabilitation.

Amendments concerning conditions and time limits for payment of benefits

The amendment harmonises the payment of benefits within 30 days from the date on which details are given of the last circumstance necessary to establish entitlement to the benefit.

Amendments concerning transfer of funds from benefits abroad

Since the amendment, benefits have been paid to persons residing abroad only in non-cash form in Poland. However, at the request of the recipient, the benefit can be transferred to a foreign bank account in an EU/EFTA State or in a State with which an international agreement on social security coordination has been concluded.

The amendment applies from 1 January 2022.

It has been made easier to acquire agricultural pension rights. Before amending the Act, farmers who had reached retirement age had to stop their agricultural activity in order to obtain a full agricultural pension (i.e. in respect of contributory and supplementary parts). Since the entry into force of the Act, farmers may receive a full pension without having to cease their agricultural activity.

It also introduced the possibility to credit, in respect of periods of active military service in the Polish Army or equivalent periods thereof or periods in alternative form of such service prior to 1 January 1999, to the contributory part of the agricultural pension.

Important amendment:

The Act of 9 June 2022 amending the Personal Income Tax Act and certain other acts (Journal of Laws 1265) introduced an amendment to cover the health insurance of children in receipt of survivors' pensions, which became applicable on 1 July 2022. Prior to 30 June 2022, children under the age of 18 who were in receipt of a survivor's pension were covered by compulsory sickness insurance and were therefore entitled to health benefits in kind at the expense of Poland.

Since 1 July 2022, however, children up to the age of 18 who receive a survivor's pension and reside in the territory of an EU or EFTA Member State, or of the United Kingdom of Great Britain and Northern Ireland, no longer have the status of insured person in Poland but retain the right to health benefits in kind, being considered non-insured recipients.

The amendment does not affect the rules for determining which State is competent to finance health benefits in kind on the basis of the rules on the coordination of social security systems provided to children entitled to a survivor's pension up to the age of 18 in a Member State of the EU, EFTA or the United Kingdom other than Poland. This means that Articles 23 to 25 of Regulation (EC) No 883/2004 of the European Parliament and of the Council on the coordination of social security systems apply when determining whether Poland is competent to finance health benefits in kind for that group of recipients.
