Short description of the ministry / ministries involved

The Vocational Training Act has the following purpose and objectives: Professional and personal development and integration into society and working life; practical relevance; maintenance of the competitiveness of businesses; balance of educational opportunities in social, regional, and international contexts; de facto equality between men and women; elimination of discrimination against persons with disabilities; permeability of educational courses; transparency of the Vocational education and training (VET) system; as well as international cooperation and mobility of learners.

Among other duties, the Office for Vocational Education and Career Counselling supervises VET. It is subordinated to the Ministry for Home Affairs, Education and Environment. The Government is assisted by the Vocational Training Council, which is composed of a maximum of seven members, including representatives from professional organizations, one representative from school-based VET, as well as one representative from the Office of Education, and the Office for Vocational Training and Career Counselling, respectively. The Office for Vocational Training and Career Counselling, study and career guidance for adolescents and young adults up to age 25, free of charge.

- Enhance the quality of apprenticeships in VET
