# Andean (Colombia – Ecuador – Peru)

- **TSD Subcommittee and Trade Committee:**
  - 3-5 December 2025 (Lima)
  - Next in November 2026 TBC (Quito)
- **Targeted update:** technical dialogue on-going
- **SEP TSD complaint against Peru and Colombia:** implementation with Peru of the list of activities. Colombia adoption of limited amendments to the labour code
- **New Complaint against Ecuador:** workers protection in the banana sector

# Angola SIFA

- **Investment Committee**  
3 March 2026 (Brussels, TBC)
- **Civil Society Forum**  
2 March 2026
- **Angola has ratified all fundamental ILO Conventions**  
(8 ILO Conventions ratified in 2025, of which 2 fundamental)
- Focus in discussions: implementation and link to cooperation projects to support both on labour and environment

# Central America

- **TSD Board:** in June 2026, TBC (Brussels)
- **Targeted update of the TSD aspects:** on-going technical dialogue

# Chile

- **Entry into force of the ITA on 1st February 2025**
- **First TSD Committee:** 4 November 2025  
(Brussels)



# Canada

- **16th EU-Canada CETA DAG:** 4 December 2025 focused on the preparation of the intersessional meeting and the upcoming TSD Committee
- **2nd TSD Intersessional Meeting with DAGs and DAG Chairs:** 16 December 2025
- **Joint Committee at Ministerial level:** 5 March 2026
- **Civil Society Forum:** 2-3 June 2026 (TBC)
- **TSD Committee:** 4 June 2026 (TBC)

# Vietnam

- **TSD Committee:** 21-22 January 2026, including Joint Forum
- **Two SEP Complaints:** focusing on labour and environmental issues with HR aspects
- **Trade Committee:** 26 September 2025
  - New EU-VN **Task Force**
- **Comprehensive Strategic Partnership**
  - **Priority on Labour issues:** ratification ILO C87

# Japan

- **Japan, Korea, Singapore "Jumbo" DAG**  
16 December 2025
- **7th Joint Dialogue with Civil Society,**  
4 March 2026 (Tokyo)
- **7th Committee and TSD**  
18 March 2026 (online)
- Japan decision to ratify C155; up-dated its NAP on Business and Human rights; moving into an ETS + some movement on official nominations of DAG members

# Republic of Korea FTA

- **Next TSD Committee and Civil Society Forum**  
– probably in September 2026 (Seoul)

# New Zealand

- **Next TSD Committee** end-April/beginning May (Wellington or online)
  - **Intersessional TSD Committee meeting** beginning of March; focus on trade and forests and trade and climate
- **EU DAG – 2nd meeting on 28 January 2026**

# Kenya EPA

- **After the 1st TSD Committee in 2025:** follow-up discussion on climate change in spring 2026
- **2nd TSD Committee meeting (2026 date TBC)**
