### **COMPETENT AUTHORITY**

- Customs Authority,
- acceptance carried out by: Customs Department, Ministry of Finance and Revenue Administration Regional Office in Gdańsk,

### **FLEGT LICENCES**

- 265 licences (1 January 2017 – 13 September 2017),
- 30 importers registered in TRACES (including 11 customs agencies),
- use of TRACES

### **OBSERVATIONS**

- (initially) doubts concerning correctness of issuance of FLEGT licences,
- mismatch of tariff classification,
- incorrectness of the customs-related obligations,
- (still) little awareness of importers,
- concerns over correctness of the reporting

### CHAPTER 44 WOOD AND ARTICLES OF WOOD; WOOD CHARCOAL (TN701)

**4409** Wood (including strips and friezes for parquet flooring, not assembled) continuously shaped (tongued, grooved, rebated, chamfered, V-jointed, beaded, moulded, rounded or the like) along any of its edges, ends or faces, whether or not planed, sanded or end-jointed : (TN701)

## INCORRECTNESS OF THE CUSTOMS-RELATED OBLIGATIONS

- **release for free circulation prior to validation of the relevant FLEGT licence**

An agreed procedure:

- submission of the FLEGT licence by an importer/customs agent to TRACES,
- providing Competent Authority with the FLEGT licence for acceptance,
- providing the customs office indicated by the importer with the information on the validation of licence),
- validation of the FLEGT licence in TRACES

## INCORRECTNESS OF THE CUSTOMS-RELATED OBLIGATIONS

- **release for free circulation prior to validation of the relevant FLEGT licence**

### **Instances of:**

- **submission of the licence to the Competent Authority for acceptance after release of the goods for free circulation (air transport)**
- **entering in customs declaration in box 44 code Y057, no submission of FLEGT licence for validation (air transport)**



# INCORRECTNESS OF THE CUSTOMS-RELATED OBLIGATIONS

## A point for consideration:

- a new TRACES functionality that would enable to send notification on acceptance of the licence not only to an importer who manages licences in TRACES by himself, but also to customs agents to ensure that they are aware that the licence has been accepted

## INCORRECTNESS OF THE CUSTOMS-RELATED OBLIGATIONS

- **shipments of FLEGT-licensed products in consignments containing commercial goods the total value of which does not exceed EUR 1000 ?**

*„[FLEGT] Valid for goods travelling **from ID to the EU through another country when not stoppage or commercial transaction has taken place in the intermediate country.**”*

## CONCERNS OVER CORRECTNESS OF THE REPORTING

### Doubts:

- **At what point should Indonesia be informed on mismatch of classification?**
  - at the time of acceptance of the FLEGT licence almost always there is no information on what CN code will be used in the customs declaration
  - the time between acceptance of the licence and the actual release for free circulation may be long
  - information in TRACES on the clearance of a shipment does not have to be real time
- **What statistical information is TRACES meant to reflect?**
  - is it meant to mirror electronically FLEGT licences issued by ID or to provide information on what actually has been released for free circulation (a functionality in „Clearance” section to indicate the codes of clearance)
