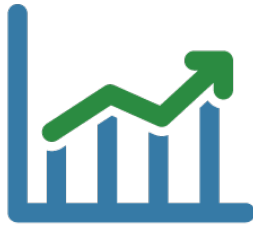

Selection Procedure (members)

Members shall be organisations having activities within the European Union in at least one of the following steps of the tomatoes, citrus fruit, pip fruit and stone fruit supply chains: producers and producers' organisations; processing and manufacturing industry, trade operators, distributors and retailers, and consumers. The group shall be divided in 4 sub-groups: Tomatoes; Citrus fruit; Pip fruit; Stone fruit. Each sub-group shall consist of a maximum of 20 participants nominated by the member organisations, up to a maximum of 2 representatives per organisation.
